Memo No. R&E/1-12/GDS/2015-19 dated at Bengaluru 560001 the 05.05.2020

Sub: Allotment of Surplus qualified candidates in respect of competitive examination for promotion to the cadre of PAs/SAs from Gramin Dak Sevaks (GDS) for the vacancy for the year 2015-16, 2016-17, 2017-18 & 2018 held on 15.09.2019(Sunday).

In continuation of this office memo no. R&E/1-12/GDS/2015-19 dated 20.02.2020, the list of surplus qualified candidates for vacancies for the year 2015-16, 2016-17, 2017-18 & 2018, who are selected for promotion to the cadre of Postal Assistant/Sorting Assistant on merit, to the extent of vacancies, are shown in Annexure-I, II,III, IV. The surplus result has been compiled taking the scores of candidates in Paper-I as merit. The candidates are being allotted to other Divisions where the vacancies remained unfilled, after going through their place of choice and their category, to the extent of available vacancies. These candidates will not be considered for transfer under Rule 38 before completion of required service in the allotted Division. These candidates will not be repatriated to his/her parent division/unit even to his/her substantive post in the lower grade so long as he/she continues in the clerical cadre in the new division/unit. Their representations, if any received to that effect will not be entertained in Circle Office and therefore they should be disposed off at Divisional/Regional level itself.

2. In respect of candidates of a particular Division who scored equal marks, their inter-se seniority is fixed as per the rules on the subject. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website and www.karnatakapost.gov.in.

3. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Region/Divisional office and units. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of Surplus candidates, as the case may be.



4. It may be ensured that no provisional candidate is given appointment without regularization of the their candidature. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office.

5. Since the examination has been conducted using OMR answer sheets, the request for re-totaling/revaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act.

a) Candidates, who wish to have the copies of OMR answer Sheets supplied are required to pay a fee of Rs.25/- per paper plus Rs.10/- towards fee for application under RTI Act in the post office and submit their applications through the Division/Unit concerned authenticating Roll no. of the candidate (through proper channel only) along with the receipt for payment of fee in original.

b) The period of preservation of OMR answer paper is one year from the date of declaration of this result. Therefore applications received after one year for supply of photo copies of answer paper will not be entertained.

c) Photo copies of answer paper will be supplied only to the candidates who appeared for the examination. Therefore the candidates should invariably intimate their Roll Number in the application under RTI Act.

6. The candidates who have been declared successful vide this office memo no. R&E/1-7/2018 & 19/III dated 20.03.2020 & 20.04.2020 for promotion to the cadre of Postman/Mailguard, held on 29.09.2019 and also declared successful vide this memo for promotion to the cadre of Postal Assistant/Sorting Assistant are required to submit declaration either accepting promotion to the cadre of Postman/Mailguard or Postal Assistant/ Sorting Assistant in the given proforma. Copy of declaration proforma is attached. Regions/Divisions are requested to keep such declaration in Service Book/Personal file of the candidate and send a copy of the same to CO within 11.05.2020.




7. After allotment of surplus candidates, two (02) UR vacancies for the year 2015-16 remained unfilled which are being offered to the candidates who are next in the merit. The allotment is placed in Annexure-V.

8. All other conditions detailed in this office memo of even no. dated 20.02.2020 hold good.

9. The results and the contents of this memo may be brought to the notice of all concerned.


