In pursuance to instructions contained in Directorate's letter no. 24-51/2022-SPG-II dated 02-09-2022, the Circle Relaxation Committee met on 03-01-2023 to review and consider the cases (already placed before main CRC dated 10-05-2022)of dependents of those deceased officials of the Department who had expired before 01-01-2016 by calculating points for family pension as per 6th CPC for appointment on compassionate grounds in relaxation of normal Recruitment Rules for Postal Assistants/Sorting Assistants, Postman/Mail Guard and Multi-Tasking Staff posts for the vacancy year 2021.

2. The Committee examined 15 cases in this review CRC which includes review of 12 cases which were already examined and considered by the main CRC dated 10-05-2022 and 3 other old cases.




