

4. This is a promotional examination and no reservation in promotion for OBC and EWS candidates, hence, the minimum qualifying percentage of UR category will be applicable for them.
5. The conditions prescribed in Directorate's F No.W-17/10/2023-SPN-I-DOP dated 06-03-2023 is applicable to the candidate declared successful for promotion through LDCE to PA/SA Cadre for vacancy year.
6. The successful candidate may be directed to accept / decline his place of posting on promotion by 16th June 2023, failing which his promotion will be deemed to be declined.
7. The Head of Unit of the selected candidate should be instructed to take necessary action for joining of newly selected candidate as per extant provisions. The Divisional head is requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process to be completed on or before 20-06-2023.
8. The selection of the candidate is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate's letter no. X-7/6/2022-SPN-II dated 17-05-2023.
9. All other terms and conditions mentioned in this office memo of even no. dated 23-05-2023 holds good.
